- Pursuant to Regulation 33 of the SEBI (Listing Obligation & Disclosure Requirement) Regulation 2015, approved the Un-audited Standalone and Consolidated Financial Results of the Company for the quarter ended 30th June, 2021 along with Limited Review Report from the Auditors. - 6. The Board has authorized Mr. Rahul Timbadia, Managing Director of the Company and Mr. SandipTimbadia, Chief Financial Officer of the Company to evaluate the opportunities for commercial utilization of land by Company at the following places:

 - ii. 332.34 Gunthas located at Village Hedvali, Taluka Sudhagad, Khapoli Pali Road, District Raigad, in the State of Maharashtra
 - iii. 251 Gunthas located at Village Ashre, Taluka Sudhagad, District Raigad, in the State of Maharashtra

This Statement, which is the responsibility of the Company's management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34"), prescribed under Section 133 of the Companies Act, 2013, and other accounting principles generally accepted in India and in compliance with Regulation 33 of the Listing Regulations.
