CHIEF JUSTICE OF India DY Chandrachud has urged citizens not to miss the opportunity to vote in the general elections, saying that it is one of the "foremost duties" in a constitutional democracy. In a video message for the Election Commission's My Vote My Voice mission for the 2024 Lok Sabha polls, Justice Chandrachud said, "We are citizens of the world's largest democracy, which is

"The Constitution gives us a multitude of rights as citizens but it also expects that each of us performs the duty, which is cast upon us. And one of the foremost duties of citizenship is to cast a vote in a constitutional democracy," he said.

our country."

"I will request every one of you please do not miss this opportunity to vote responsibly as citizens of our great motherland. Five minutes, every five years for our nation. It's doable, isn't it? Let's vote with pride. My vote, my voice," the CJI said.

Justice Chandrachud said the citizens have a participatory role in electing the government and that is why it is said that "this government is a government of the people, by the people and for the people."

He recalled his excitement as the first time voter and queuing up at the polling booth to exercise the franchise.

"The ink on the finger when I vote allows tremendous feelings of patriotism and association with the nation...," he said.

"So our Constitution and our law provides for one citizen, one vote and one value. I think that's the great tenacity and the power of our nation as a constitutional democracy," he said.

### Musk puts off India visit

Party general secretary Jairam Ramesh said in a post on X,"The INDIA (alliance) government will promote electric vehicles even more aggressively — I myself am a user of one!"

Under India's new EV policy, global automakers will be allowed to import completely built-up units (CBU) at a concessional import duty of 15% for vehicles which are priced (cost, insurance & freight) \$35,000 and above for a period of five years. However, they will be required to set up manufacturing facilities in the country within a three-year period.

For companies that are not opting for this route, CBUs priced more than \$40,000 will continue to attract 100% duty and those below it, at 70%. The 15% concessional import duty is the same which is applicable for completely knocked down (CKD) units, which are assem bled in the country.

### Sustainability calling: Green is the new premium in realty

The March report by Xynteo says residential consumers are willing to pay 5% to 10% premium for green buildings, while office occupiers are willing to pay more than 15% for green buildings and as much as 50% premium for totally net zero buildings.

Corporate occupiers are increasingly leasing green office spaces, with over 85% motivated by energy savings and sustainability targets, and 74% willing to pay higher premiums for lower emissions buildings. The survey also says 42% of India's top seven cities' Grade A office stock is already green-certified.

# HDFC Bank net profit up 37% at ₹16,512 crore

The numbers are not strictly comparable on a year-on-year basis as a result of the merger of HDFC Bank with mortgage lender HDFC that came into effect from July 2023.

The net interest margin of the lender remained stable at 3.6% in the fourth quarter, which was the same level as in the third quarter. The bank managed to improve its current accountsavings account (CASA) ratio sequentially, which increased to 38.2% in the fourth quarter from 37.7% in the third quarter.

The private lender witnessed healthy loan growth



increased by 55% year-onyear to ₹24.84 trillion as of March-end, while total deposits grew 26% to ₹23.79 trillion. The bank witnessed a

slight deterioration in its asset quality as its gross non-

performing assets came at 1.24% of gross advances as on March 31, as against 1.26% as on December 31, 2023, and 1.12% as on March 31, 2023. Provisions during the quarter rose three times quarter-on-quarter to

₹13,512 crore. The bank announced that its board of directors recommended a dividend of ₹19.5 per equity share of ₹1 for the year ended March 31. During the last quarter, the bank's net revenue surged to ₹47,240 crore, inclusive of transaction gains of ₹7,341 crore from the stake sale in subsidiary HDFC Credila Financial Services during the quarter.

### BJP wants to continue loot: Cong slams FM

Following a directive from the apex court, the State Bank of India, which was the authorised seller of electoral bonds, shared data on electoral bonds which was then made public.

The Congress has alleged that the electoral bonds data has exposed "corrupt tactics" of the BJP such as quid pro quo and grant of "protection" to companies against donations. Rajya Sabha MP Kapil Sibal

also on Saturday said the BJP is claiming that the electoral bonds scheme was brought for transparency but the Supreme Court had stated the opposite while declaring it "unconstitutional". "Nirmala Sitharaman has said in an interview that we will bring back electoral bonds and it was also said in the interview that when electoral bonds were introduced, they were introduced for the sake of transparency. This is exactly the opposite of what the Supreme Court stated," Sibal said in a press conference. The Supreme Court has said that these are not "transparent" and were brought in a "non-transparent manner", he said.

"Now the problem they (BJP) are facing is that they have money for this election but they know that they will need the money when they lose. However, Nirmala ji is saying (they) will win and bring it (electoral bonds scheme) back," Sibal said.

### Crop diversification still last on Punjab farmers' mind

"Without price assurance we would not be shifting out of growing paddy and wheat, Mandeep Singh, a farmer from Fatehgarh Sahib district, Punjab, said. "Unless farmers are not assured of MSP purchase, crop diversification would not happen," Manjinder Singh, secretary, mandi committee at Khanna, which is Asia's biggest grain market in terms of daily arrivals, said. He said the government should set a bench mark purchase price for pota toes as well so that farmers are encouraged to grow it.

Pitching for crop diversification, the economic survey (2023-24) of the Punjab gov ernment had recently stated that the cropping pattern of growing water-intensive rice and wheat along with free electricity supplied to farmers has resulted in depletion of ground water levels, and the model is 'economically and ecologically unviable'.

Stating that yield of cereals, pulses and oilseeds in Punjab has been higher compared to national average, the survey has noted "yields are stagnating in wheat and rice and it is another reason for crop diversification to be the way forward".

But MSP purchases for more crops is not seen as a solution by experts. Ashok Gulati, agricultural economist and former chairman, commission for agri cultural costs and prices (CACP) said, "In Punjab, it's important to ensure that farmers move away from paddy and wheat. In order to do that, a lumpsum amount of ₹25,000 to ₹30,000 per hectare may be given to farmers who grow less water guzzling crops like pulses, oilseeds, millets and maize." Making MSP legal and forc-

ing the private sector to buy at MSP is not practical or desirable, Gulati said: "One can make MSPs for these crops effective by asking government agencies such as Nafed to procure whenever market prices go below MSP."

# राणा कपूर को और जेल में रखना 'सुनवाई से पहले सजा' की तरह : कोर्ट

मुंबई, 20 अप्रैल (भाषा)।

मुंबई की एक विशेष सीबीआइ अदालत ने धोखांधडी के मामले में यस बैंक के संस्थापक राणा कपुर को जमानत दे दी। साथ ही कहा कि बिना मुकदमे के उन्हें कारागार में रखना 'सनवाई से पहले सजा' के समान होगा।

अदालत के इस आदेश के बाद बीते शुक्रवार शाम को उन्हें जमानत पर जेल से रिहा कर दिया गया। यस बैंक के संस्थापक राणा कपूर को पहली बार मार्च, 2020 में प्रवर्तन निदेशालय (ईडी) ने धनशोधन के मामले में गिरफ्तार किया था। ईडी और केंद्रीय जांच ब्यूरो (सीबीआइ) ने यस बैंक में कथित धोखाधड़ी को लेकर राणा के खिलाफ कुल आठ मामले दर्ज किए हैं। विशेष सीबीआइ न्यायाधीश एमजी देशपांडे की अदालत ने राणा कपूर की जमानत याचिका पर सुनवाई के दौरान कहा कि इसका कोई न्यायोचित तर्क नहीं है कि अन्य मामलों में पहले ही चार साल कारागार में बिता चुके आवेदक को और हिरासत में क्यों रखा जाना चाहिए।

# आपात निकास सुरंग का काम पुरा

जनसत्ता ब्यूरो नई दिल्ली, 20 अप्रैल।

सिवोक-रंगपो रेल परियोजना के लिए 855 मीटर लंबी आपातकालीन निकास सुरंग के लिए काम पूरा हो गया है। इस परियोजना के तहत सिक्किम को पहली बार रेल नेटवर्क से जोड़ा जाएगा। अधिकारियों के अनुसार सुरंग का 20 मीटर का हिस्सा राष्ट्रीय राजमार्ग-10 के नीचे तीस्ता नदी के निकट हैं।

उन्होंने बताया कि इसकी नरम मिट्टी में खनन करना परी परियोजना का सबसे चुनौतीपूर्ण काम था क्योंकि इसके धंसने के अधिक आशंका थी, जिससे सिक्किम का देश के बाकी हिस्सों से सड़क संपर्क ट्ट सकता था। परियोजना से जुड़े 'इरकान इंटरनेशनल' के एक अधिकारों ने कहा कि राष्ट्रीय राजमार्ग-10 एकमात्र सड़क नेटवर्क है जो सिक्किम को देश के अन्य हिस्सों से जोड़ता है।

राजमार्ग से 18 मीटर नीचे सुरंग खोदना हमारे लिए एक बड़ी चुनौती थी, क्योंकि मिट्टी बहुत नरम और भुरभुरी होती है। रेलवे अधिकारियों ने बताया कि उन्होंने आधुनिक विधि का इस्तेमाल किया। भारतीय प्रौद्योगिकी संस्थान ( आइआइटी) द्वारा इसकी जांच करने

के बाद, इरकान के अधिकारियों ने खनन कार्य की सरलता को समझाते हुए एक ह्यकेस स्टडीह्न की।

# आरोपी की मां ने अपने बेटे को कड़ी सजा देने की मांग उठाई

हुबली, 20 अप्रैल (भाषा)।

कर्नाटक के हबली स्थित एक कालेज परिसर में कांग्रेस पार्षद की बेटी की हत्या के आरोपी यवक फयाज की मां ने मृतका के परिवार से अपने बेटे के कृत्य पर माफी मांगी और उसे कड़ी सजा

देने की मांग की। हुबली-धारवाड़ नगर निगम के कांग्रेस पार्षद निरंजन हिरेमथ की बेटी नेहा (23) की गुरुवार को बीवीबी कालेज के परिसर में कथित तौर पर चाक मारकर हत्या कर दी गई। वह एमसीए प्रथम वर्ष की छात्रा थी जबकि फयाज उसका पूर्व सहपाठी है।

की मांग करते हुए राज्य के कई हिस्सों में प्रदर्शन हुए हैं। उसे 18 अप्रैल की घटना के सिलसिले में गिरफ्तार कर लिया गया है। पेशे से शिक्षिका एवं आरोपी की मां मुमताज ने कहा, 'मेरे बेटे ने जो कुछ किया, उसके लिए मैं कर्नाटक के लोगों से और नेहा के परिवार से माफी मांगती हं। यह नेहा और उसके परिवार के साथ हुआ बड़ा अन्याय है।' उन्होंने धारवाड़ में संवाददाताओं से कहा, 'मेरे बेटे ने जो कुछ किया वह पूरी तरह से गलत है और हमारा सिर शर्म से झ़क गयाँ है। उसने जो कुछ किया वह एक बड़ी गलती है और उसे देश के कानून के अनुसार कड़ी सजा मिलनी चाहिए।' उन्होंने कहा कि उनका

फयाज खोंदुनाइक (23) को मौत की सजा देने

बेटा और नेहा महज दोस्त नहीं थे बल्कि वे एक-दसरे से प्रेम करते थे और शादी करना चाहते थे। मुमताज ने कहा, 'मेरा बेटा बहुत मेधावी है और एलकेजी और यूकेजी कक्षाओं से ही 90 फीसद से अधिक अंक हासिल किए हैं। वह भारतीय

प्रशासनिक सेवा (आइएएस) का अधिकारी बनना चाहता है।' इस बीच, कर्नाटक के कर्नाटक के एक पूर्व मुख्यमंत्री जगदीश शेट्टार ने शनिवार को कालेज परिसर में मृतका के परिवार से मुलाकात कर घटना कांग्रेस पार्षद की पर दुख जताया। उन्होंने कहा, 'यह एक बेटी की हत्या का अमानवीय कृत्य है। फयाज ने जिस तरह से नेहा की हत्या की, वह अमानवीय है। मैं आग्रह करता हुं कि राज्य सरकार, मुख्यमंत्री

और गृह मंत्री विषय की निष्पक्ष एवं त्वरित जांच कराए।' इस घटना को लेकर राज्य में सत्तारूढ कांग्रेस और विपक्षी भाजपा के बीच राजनीतिक आरोप-प्रत्यारोप का दौर शुरू हो गया है।

कांग्रेस इसे व्यक्तिगत पहलू वाली घटना बता रही, जबिक भाजपा ने इसके 'लव जिहाद' होने का संदेह जताया है और कहा कि यह राज्य में कानून व्यवस्था के बदतर होने का संकेत देता है। पुलिस के एक वरिष्ठ अधिकारी के अनुसार, फयाज ने नेहा पर चाकू से कई वार किए थे। जांच के दौरान आरोपी ने दावा किया कि उन दोनों के बीच प्रेम संबंध थे लेकिन नेहा बाद में उससे दूरी बनाने लगी थी। मृतका का परिवार आरोपी को फांसी की सजा देने की मांग कर रहा है।
