## Thane crime rises, detection rates soar

At least 12,104 crimes were reported in the Thane Commissionerate in Maharashtra in 2023, of which 73 per cent of the offences have been detected, a police official said on Tuesday.

In 2022, as many as 11,961 offences were reported in the limits of the commissionerate with a detection rate of 70 per cent and the number of crimes increased by 143 in 2023, the official said.

As per data shared by the additional commissioner (crime), Punjabrao Ugale, Thane recorded 87 murder and 159 attempted murder cases in 2023, which is a slight decline from the previous year's 93 and 140 cases respectively. At least 17 cases of dacoity and 581 robberies were reported in the commissionerate in 2023, and the detection rate had improved from 65 per cent to 78 per cent this year, the data revealed.

Cases of rioting went up to 231 in 2023 compared to the previous year's 205, while 415 rape cases were registered compared to the previous year's 432, it was stated.

Thane Commissionerate includes Thane city, Bhiwandi, Kalyan, Ambernath, Ulhasnagar and Badlapur.

## Man clubs grandmother to death, held

A 70-year-old woman was allegedly bludgeoned to death with a wooden rod by her grandson, who was apparently under the influence of liquor in Palghar district of Maharashtra, police said on Tuesday.

The woman was killed on Monday night in her Umbarwadi village in Jawhar taluka, following which the accused was arrested.

"When the 23-year-old man, Dharmaveer Vaze, was having dinner at home, he heard his grandmother, Anandi Tokhre, complaining and murmuring to herself. This annoyed him and in a fit of rage, he hit her with a wooden rod, killing her on the spot," an official of Jawhar police station said.

The accused was under the influence of liquor at the time of incident, he said.

An offence under Indian Penal Code (IPC) section 302 (murder) was registered and the victim's body was sent for post-mortem to a government hospital.

After being alerted, a police team rushed to the spot and arrested the accused.

## Fake website scam targets Andheri hotel

Hotel Suba International filed a case against an unidentified person for allegedly creating a fake website of their hotel. The case was filed at Andheri police station on Monday.

According to the FIR, the hotel is located at Chakala Andheri East, which facilitates lodging, restaurants and a banquet hall. The official website for the hotel is [www.hotelsubainternational.co.in](http://www.hotelsubainternational.co.in), and customers can contact the hotel for bookings through the official hotline number 02267076707.

On January 8, at 12 pm the hotel's reception received a call from a person who claimed to have booked a room at Suba International Hotel and paid in advance but did not receive any confirmation. The hotel staff checked their records but found no such booking. Subsequently, the hotel's IT team surfed online and discovered a duplicate website of the hotel. The fake website provided contact details such as [subainternational@gmail.com](mailto:subainternational@gmail.com) and 9244274449 which were connected to the fraudsters, who's website retrieved information from the real website, leading to multiple customers booking through the fake sites and made payments to the false HDFC and Bank of Baroda accounts.

After complaints, the hotel's IT assistant Ajay Dinagle, filed a case against an unknown person under sections 419 (cheating), 465 (forgery), 468 (forgery), and 471 (using as genuine a forged document).

## Talathi exam result protest: Rail Roko at Dadar by Cong

Youth Congress workers organised a 'rail roko' agitation at Dadar station on the Western Railway line, demanding the cancellation of results for the Talathi (village revenue official) recruitment examination. The protest, which led to the temporary disruption of a Borivali-bound train, unfolded on Tuesday around 3.15 pm.

According to an official from the Government Railway Police (GRP), 20 to 25 Youth Congress workers participated in the protest, aiming to draw attention to alleged irregularities in the recruitment process. The protesters insisted on a thorough investigation of the results, claiming that some candidates had obtained scores exceeding the maximum limit, suggesting potential manipulation.

According to an officer of Western Railway, the agitation caused a brief delay of up to 5 minutes for a few trains.

Youth Congress demands probe into Talathi exam irregularities

The protest was peacefully resolved by personnel from the GRP, RPF and city police, who managed to convince the youth Congress workers to clear the tracks by 3:30 pm.

The Congress party, which has been vocal about its concerns regarding the Talathi recruitment process, alleges foul play in the examination conducted by the state revenue

department. "The party contends that the results indicate possible rigging, with certain candidates obtaining scores beyond the prescribed limits. As a response, the Congress has called for the cancellation of the examination results" said a worker who was part of the agitation.

The state revenue department had organised the Talathi recruitment exam, attracting a significant number of aspirants, with lakhs of students appearing for the competitive test. "The Youth Congress, acting as the voice of dissent, now seeks a comprehensive investigation into the alleged discrepancies, urging authorities to ensure transparency and fairness in the recruitment process" said a leader of Youth Congress.

## Rising leprosy cases among children spark health concerns

SWAPNIL MISHRA / MUMBAI

Rising number of leprosy cases among children below 18 years in Maharashtra is a major concern for the state's health department. Out of 17,048 new leprosy cases identified between April and December last year, 1,160 cases, constituting seven percent, involved children. Officials attribute this rise to the good detection and coverage done by paramedical staff, along with the health department's measures to eradicate leprosy.

An official from the state health department said, the detection of cases among children is a sensitive indicator as they can get infected by leprosy patients via close contact for which there is a need for urgent intervention and measures to control these cases. Moreover the risk of being stigmatized, bullied and shunned for lifetime increases and affects their mental health.

While leprosy is non-fatal and doesn't easily spread, early diagnosis and treatment can effectively cure it. The incubation period for leprosy-causing bacteria, Mycobacterium leprae, ranges from six months to two years.

Dr Sunita Golhait, Joint Director (TB), health services, Maharashtra said "Due to their weak immunity, children in homes with infected adults are most vulnerable to Mycobacterium leprae [leprosy-causing bacterial]." Despite the decrease in leprosy cases among children from 12 percent in 2010-11 to the current 5-6 percent of overall cases, the World Health Organization notes that leprosy remains endemic in several Indian states.

Bombay Leprosy Project, Dr Vivek V Pai, said, "Leprosy among children indicates there is community transmission. An immediate surveillance of the area where cases have been found in children is required to identify index cases and hotspots. Index cases have to be traced and treated effectively to break the chain of transmission."

## Online match proves costly for Tardeo man

A 31-year-old man from Tardeo became the latest victim of sextortion after downloading the OkCupid app for online dating.

The incident occurred on the night of January 20, when the complainant, Ajit (name changed), downloaded the app and was looking for matches. When his profile matched with a woman named Harshita Jain, they started talking and exchanged their contact numbers, shifting their conversation to WhatsApp, said Ajit in his statement to the police.

While chatting, Jain video-called Ajit out of the blue, and appeared naked on the screen. Confused and scared, Ajit said he immediately disconnected and blocked her number. Jain, using another phone, requested him to un-

block her as she wanted to talk more.

They resumed their video call where she demanded him to remove his clothes and after some time they disconnected the call. Some time later, Ajit received several photos and videos on his WhatsApp from Jain, where he was naked. She allegedly threatened him about sending these media files to Ajit's friends and relatives, and kept blackmailing him about uploading the videos on social networking sites. She then demanded Rs.1 lakh money to delete the photos and videos.

The complaint paid Rs.3.6 lakh before running out of money. He never heard anything from them and later on Monday afternoon approached the Tardeo police and registered an offence against an unknown person.

## MBMC guides 1st batch of SSC students ahead of board exams

Introduces bar codes, holocraft stickers, UID numbers and mock papers as aid

To ensure that their Senior Secondary Certificate (SSC) students do not end up making errors in board exams, the education department of the Mira Bhayandar Municipal Corporation (MBMC) has organised a series of sessions to guide them on various aspects, including subject-wise preparation, scoring methods, paper presentation, unique identification (UID) codes, affixing bar-code and holocraft stickers for their examinations beginning February 1. The holocraft stickers were introduced to avoid revealing the identity of the student and to ensure unbiased evaluation.



Notably, this is the first batch of 190 students from four municipal schools, including three Marathi medium and one Urdu medium, who will be appearing for the SSC examinations after the MBMC elevated education facilities from Class 8 to Class 10.

Additional municipal commissioner Dr Sambhaj Panpate said, "In board examinations, paper presentation

matters a lot. Apart from general sessions and mock examinations, individual attention is being given to each student, which will not only make them aware about the technical aspects but also help them organise their paper in the best way."

The session will be conducted in three phases. With the directions of municipal commissioner Sanjay Katkar, the education department has roped in experienced moderators and teachers to guide the students.
